Kaos GL: We were, we are and we will be here!

"We have not asked anyone's permission to exist, and we will not... We were, we are and we will be here!"

Kaos GL [made a statement](#) regarding IDAHOBIT2020:

"On May 17, 1990, the World Health Organization declassified homosexuality from the list of mental disorders. Since 2004, the International Day Against Homophobia, Transphobia, and Biphobia has been celebrated to attract the attention of the public, authorities, media, and politicians to the hate, discrimination and rights violations that LGBTI+'s are subjected to. As Kaos GL, we have been celebrating May 17th with various events since 2006."

The smear campaign against LGBTI+'s on the state TV channel TRT 1

LGBTI+'s were targeted in the "What's the Truth" program, which airs every day at 19.40 on public television TRT 1.

[At May 25 the program](#) was about what happened after the Religious Affairs Administration of Turkey's hate khutbah, while LGBTI+'s were targeted with the following words: "All kinds of illegitimate sexual intercourse".

The program also legitimized the discriminatory remarks of the Supreme Council of Religious Affairs and The Chairperson of the Turkish Bar Association Metin Feyzioğlu, and those who reacted to discrimination were accused with "highly unfair and irresponsible attitude" and making "outrageous statements".

International Reactions against Hate Campaigns against LGBTI+'s in Turkey

* 37 Members of the European Parliament (MEPs) wrote a letter to President of the Republic of Turkey, Recep Tayyip Erdoğan and Head of the Directorate of Religious Affairs, Ali Erbaş regarding hateful khutbah. MEPs underlined the

* Ahead of the 17 May International Day Against Homophobia, Transphobia and Biphobia (IDAHOBIT) Amnesty International calls on the [government of Turkey](#) to take urgent action to counter the increasing number of discriminatory statements and policies by state officials against LGBTI people: "The authorities must instead promote equality both in their statements and actions."

İmamoğlu, Mayor of İstanbul responded to the "gay marriage" question

Istanbul Metropolitan Municipality Mayor Ekrem İmamoğlu participated in the program "40 with Jülide Ateş" and [answered the questions](#) posed to him.



When asked about the headlines of "Ekrem İmamoğlu designs a project to legalize gay marriages" of discriminative newspapers and the hate khutbah of the Religious Administration of Turkey, that came after last year's discussions about the establishment of a gender equality commission in İstanbul Metropolitan Municipality, İmamoğlu said "we have a responsibility to protect the freedoms of homosexuals, but our society is not ready to allow gay marriage yet".

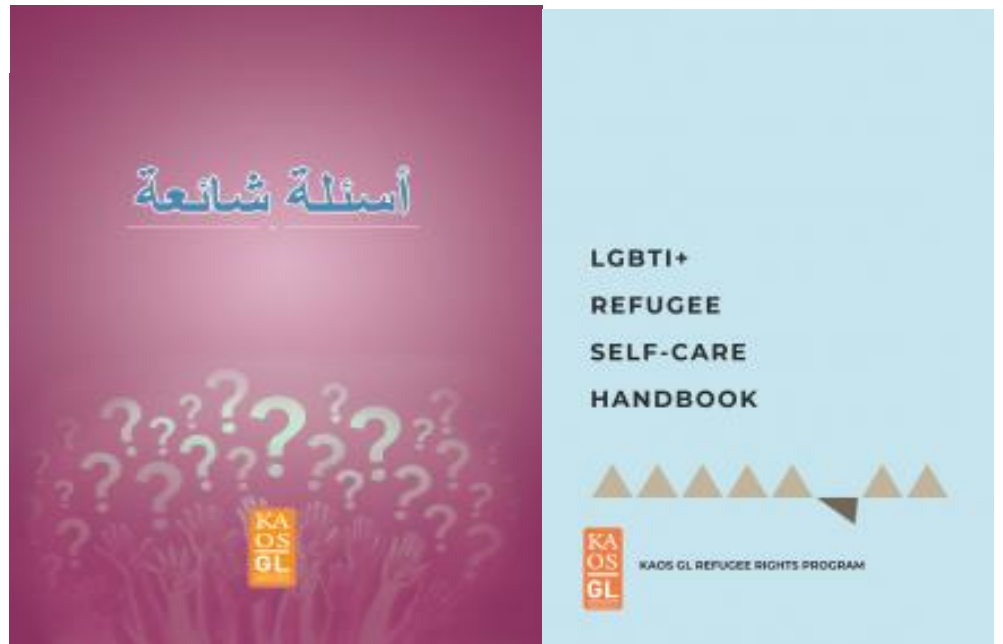


LGBTIQ+ Agenda of Kaos GL_May 2020
