Turkish Government responded UN's LGBTI+ rights question without even saying LGBTI+!

In the joint letter sent in July by independent experts and United Nations Special Rapporteurs on LGBTI+ rights, UN agencies reminded the Directorate of Religious Affairs' khutbah against LGBTI+s, hate campaigns on social media, statements by public officials against LGBTI+s, investigations against institutions advocating for LGBTI+ rights and statements by President Erdogan and emphasized the statements of public officials and religious leaders would provoke hatred.



The Government responded to this letter on September 21st. Leaving the allegations and questions unanswered, the Government argued that the "etc." statement in the Constitution's equality clause covers bases of discrimination other than the ones explicitly described in the law. The government's response to the letter, in which UN officials explicitly asked about discrimination against the LGBTI+s, did not include the expressions of "sexual orientation", "gender identity", "LGBT", "LGBTI" or "LGBTI+".

Regional Administrative Court approved the annulment of the LGBTI+ ban in Ankara

The Regional Administrative Court also approved the verdict of Ankara's 2nd Administrative Court to annul the "second indefinite ban on LGBTI+ activity" in the case filed by the Kaos GL Association.

Kaos GL Legal Coordinator Att. Kerem Dikmen commented on the verdict of the Regional Administrative Court to KaosGL.org:

"As Kaos GL, we filed a lawsuit against the general ban decision of the Governorate of Ankara, which is known as 'the second LGBTI + activity ban', and won. But upon this, the Governorate appealed to the Regional Administrative Court, which is a higher court. They demanded the reversal of the first verdict and the prohibition decision to continue. Today, with this decision of the Regional Administrative Court, the objection of the Governorate of Ankara was rejected. This decision means that the decision to annul the ban issued by the administrative court is in accordance with the law, and also that the general prohibition decisions of the Governorate of Ankara were against the law, legislation, and international conventions. With this decision, the unlawful act of the Governorate of Ankara was once again underlined. It has shown that the Governorate of Ankara cannot issue such ruling during both ordinary and extraordinary periods. From now on, another decree of a general ban by the Governorate of Ankara may constitute a crime."

17 members of HDP including Cihan Erdal, are under arrest

17 of the 20 former central executive committee members of the Peoples' Democratic Party (HDP), who were detained by the Ankara Chief Public Prosecutor's Office within the scope of the "investigation of Kobane demonstrations" which took place in 2014, were arrested.

LGBTI+ activist Cihan Erdal is also among those who have been arrested. Erdal, a Ph.D. student at The University of Carleton in Canada, was detained while in Istanbul as part of their thesis research.

LGBTI+ Elders report: The state and private sector causes rights violations

The May 17 Association published its report "LGBTI+ Elders: Situation in Turkey and Around the World" in Turkish and English.



The report prepared by Att. Yasemin Öz, discusses the place of elderly LGBTI+'s rights in national and international legislation, good examples of practice in Turkey and around the world and solution proposals. The report also involves academic studies and recommendations. The report aims to shed light on the protection of LGBTI+'s against human rights issues that could be brought by old age, among other forms of discrimination.

LGBTI+ initiatives from Diyarbakır, Denizli, Kocaeli and Adana gathered







The report, which was prepared by Att. Hatice Demir includes the legal analysis of rights violations through applications regarding HIV made to the association in 2018 and 2019.

According to the report, which aims to show the projection of rights violations based on HIV in Turkey, discrimination and stigma are so systematic, rights violations are so inured in every step from individual to state that legal basis is hardly questioned in the transactions that cause these violations.
